What is TORCH?

TORCH is a local homeschool support group serving Texarkana, AR/TX and the surrounding area. Organized and operated by parent volunteers, our mission is to support and encourage those pursuing the choice of homeschooling for the education of their children.

We believe in God, creator of all things, and in His Son Jesus Christ. TORCH is a Christian support group. Although we do not ask our members to sign a statement of faith, we do conduct ourselves in accordance with our beliefs. Discussions and presentations in meetings and in informal settings will tend to reflect the religious character of our group.

TORCH Policies

We believe that all members of TORCH play an important role in the success of our group. All members are expected to participate in a Christ-like manner and edify one another during our events. The following list outlines the requirements/expectations of each member. Should you need more information about these guidelines, please contact a TORCH board member.

1. **Family Fellowships and Programs-** Open to TORCH member families and their invited guests.
2. **Field Trips, Parties and Special Events-** Open to the children of TORCH family members who have met all the requirements set for that event (such as age, fee, sign-up, etc..). All guest must be accompanied by a TORCH parent that has invited them. That parent will be responsible for the guest throughout the entire event. There are to be no unaccompanied children.
3. **Teen Night and Spring Formal-** Only open to TORCH member children, and guest that have been approved by the TORCH body, who have met the requirements set for that event (such as age, fee, sign-up, etc..)
4. **Bowling, Skate Night, and Park Day-** Open to TORCH member, their invited guests, and visitors who are considering membership in TORCH (potential members may attend up to 3 TORCH related events prior to joining).
5. **TORCH Monthly Meeting-** Open to everyone.
6. **Cooperative Learning Clubs (Toastmasters, Art, Keepers at Home etc...)-** Open to TORCH members and visitors who are considering membership in TORCH (potential members may attend up to 3 TORCH related events prior to joining).
7. **TORCH Board Meeting-** Open to TORCH members and invited guests.
8. **Graduation and End of Year Program-** Participation in ceremonies is open to TORCH member children who have met the requirements set for the event. Observing the ceremony is open to all TORCH members and their invited guests.
9. **Fundraising-** All fundraising activities must be approved by the board. Members should submit a written explanation of the fundraiser, including what it will be, what it will finance, who will be in charge, and who will be expected to participate.
10. **Board Members-** Open to anyone who has been a member of TORCH at least 1 year. Their nomination must be in writing by a current member. Self-nominations are acceptable. Each board member is elected to a one year term, and is automatically re-nominated unless (s)he revokes their nomination.
11. **Incidents-** Should anyone have a concern about an incident involving a TORCH member, (s)he should go to the member who caused the offense and try to clear the matter up without retaliation. If the matter is not resolved (s)he should submit a letter to the TORCH board president detailing the incident and why (s)he is concerned. The letter should be limited to personally observed facts surrounding the incident and avoid ascribing motives or discussing personality and/or character issues. The president will bring the matter before the board at the next regularly scheduled meeting, or via email if the meeting is more than 1 week away. 2 board representatives will arrange a meeting with all involved parties. If the person who wrote the letter refused to attend the matter will be dropped. After meeting with all involved parties, the representatives will take the matter back to the

board to decide upon a course of action. All parties involved will be notified of the board's decision within 1 week.

12. **Secular Music/Electronic Devices-** Due to our desire to glorify Christ and uphold a standard that recognizes differing levels of conviction regarding secular music, only Christian or instrumental music will be allowed at any TORCH sponsored event. This includes the sharing of music off of personal electronics.
13. **Public Displays of Affection-** TORCH members are expected to abstain from all public displays of affection outside of the individual family unit. This includes kissing, prolonged hugging, inappropriate touching, and sitting in laps. If there is any concern regarding behavior in this area, refer to policy #11.
14. **Sexual Immorality-** As Christians, the Lord holds us to a standard of sexual purity. If it becomes evident that a member participating in TORCH is involved in sexual immorality the following actions will be taken:
 - If student pregnancy is involved, the board will seek to determine the nature of the pregnancy. If the pregnancy is the result of rape, the board will work with the student to continue involvement with TORCH.
 - If it is clearly determined that a student has been participating in sexual immorality, the student will be suspended from all closed TORCH activities for 1 year. After the 1 year suspension, the student and their parents may petition the board for reinstatement to closed activities. The board will seek to determine at that time if the student has rejected a lifestyle of sexual immorality. If the student has not come to a point of rejecting that lifestyle, (s)he will not be allowed to participate in closed activities. If reinstated and the student has a second offense, they will be suspended permanently.
 - If it is evident that a parent or guardian has chosen a lifestyle of sexual immorality, then the rules of policy #11 apply.

TORCH Fees

1. **Annual Dues-** \$25 per family/per year. Due at sign-up, and yearly by the August meeting. Dues include access to the members area of our website, a printed membership directory upon request, and membership card which is printable from the website. Student membership card can be used for discounts at participating local merchants.
2. **Cooperative Learning Clubs-** Fees for supplies, handbooks, etc.. will be the responsibility of each individual family and will be determined by the actual cost of participating. This will be determined by the group leader and will be announced as soon as determined.
3. **Miscellaneous-** There are several other activities offered that may require additional fees. These include but are not limited to Graduation, Spring Formal, parties, field trips. The fees can vary based on the actual event, and fundraisers held. Most of all costs are stated upfront, however, due to the nature of some events, it is difficult for the person in charge to have an exact amount. All parents are expected to pay for the events in which their children participate. Should a problem arise, they should immediately contact the person in charge of the event to see if something can be worked out.

Let's use these policies as an opportunity to renew our commitment to excellence in our Home Education and to each other . And let us consider how we may spur one another on toward love and good deeds. Hebrews 10:24

Code of Conduct

And above all things have fervent charity among yourselves: for charity shall cover the multitude of sins. I Peter 4:8

1. Adults and children will treat others with courtesy in speech and action and strive to be 15 minutes early for field trips they choose to attend. *Honour all men. Love the brotherhood. Fear God. Honour the king. Peter 2:17*
2. Children will also treat adults with respect as they act worthy of respect. Correction by a non-parent should be verbal only (no physical contact). Adults - *Understanding is a wellspring of life unto him that hath it: but the instruction of fools is folly. Proverbs 16: 22* Children - *Whoso despiseth the word shall be destroyed: but he that feareth the commandment shall be rewarded. Proverbs 13:13*
3. Parents are primarily responsible for the training of their children; children are to submit to their parent's authority. *Children, obey your parents in the Lord: for this is right. Honour thy father and mother; which is the first commandment with promise; That it may be well with thee, and thou mayest live long on the earth. Ephesians 6:1-3*
4. Adults and children will be positive representatives of Christ with modest appearance, in the care of public/others' property, and in abiding by host facility rules. *Whether therefore ye eat, or drink, or whatsoever ye do, do all to the glory of God. Give none offence, neither to the Jews, nor to the Gentiles, nor to the church of God: Even as I please all men in all things, not seeking mine own profit, but the profit of many, that they may be saved. Be ye followers of me, even as I also am of Christ. I Corinthians 10:31-11:1*
5. Method of Conflict Resolution
 - A. Go to the person who offends you, calmly try to clear up the matter without retaliation. *Moreover if thy brother shall trespass against thee, go and tell him his fault between thee and him alone: if he shall hear thee, thou hast gained thy brother. Matt. 18:15*
 - B. If the matter is not resolved, children---speak with your parent, adults speak with the parent of the child involved. (See #3 above) *But if he will not hear thee, then take with thee one or two more, that in the mouth of two or three witnesses every word may be established. Matt. 18:16*
 - C. If the matter has still not been resolved, the matter should be brought before the board as stated in TORCH Policy #11, which will resolve the matter after hearing from both parties, separately or jointly, at its discretion based upon the principles above. Once the matter is resolved, all parties should refrain from gossip. *And if he shall neglect to hear them, tell it unto the church: but if he neglect to hear the church, let him be unto thee as an heathen man and a publican. Matt. 18:17*

Children's Code of Conduct

1. I agree to be nice to everyone when I am at park day or on a field trip.
2. I agree to use kind words to everyone when I am at park day or on a field trip.
3. When I forget, I will know because:
 - a. My parent will remind me.
 - b. Another adult will remind me.
 - c. One of the other children will remind me.
4. When someone reminds me I broke a rule, I will try to find a solution by:
 - a. Explaining what I think happened,
 - b. Saying sorry that I did something that offended someone.
5. When another adult reminds me I broke a rule, I will follow them back to my parents if we can't fix the problem.
6. I will obey my parents. I agree that Mom/Dad is the one who will give me my consequences.
7. I agree if another adult brings me back to Mom/Dad, I will not be allowed to go back to the activity until we have found a solution.

Teen's Code of Conduct

1. I understand that only Christian or instrumental music will be played at group sponsored activities.
2. I agree to avoid using any crude language or slang that could be offensive to others.
3. I understand that TORCH teen activities are not a "dating service". The purpose for teens to participate in activities is to be group focused, to socialize or learn with everyone, not to focus on deepening a relationship with just one person of the opposite sex. What activities I pursue with one person in my free time will be based upon my parents' standards.
4. I will consider others when I choose what to wear to group functions. It's better to be modest than to show off or cause someone to be distracted or offended.
5. When I have a conflict with someone, I will follow the steps of conflict resolution and commit to try to find a solution by:
 - a. Explaining what I think happened,
 - b. Apologizing if I did something that offended someone.
6. If I'm carpooling with leaders or other group members, I will cooperate by wearing a seatbelt, not being distracting to the driver and agreeing to abide by their car rules.
7. I understand that if I am in repeat violation of the Code of Conduct that I may be subject to suspension from TORCH activities.
