

GEORGETOWN REGIONAL AREA CHRISTIAN EDUCATORS LIABILITY RELEASE

In consideration of being allowed to participate in any way in Georgetown Regional Area Christian Educators (GRACE Co-op) related events and activities, the undersigned:

1. Agree that the member/participant or parent/guardian of the participant should inspect the facilities and equipment to be used, and if the member/participant or parent/guardian of the participant believes anything is unsafe, he or she should immediately advise a SALT/Board member of such condition(s) and refuse to participate or allow their minor children to participate.
2. Acknowledge and fully understand that each member/participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions, or negligence but the action, inaction, and negligence of others, or the condition of the premises or of any equipment used. Further, there may be other risks not known to us or not reasonably foreseeable at this time.
3. Assume foregoing risks and accept personal responsibility for damages following such injury, permanent disability or death.
4. Release, waive, discharge, and covenant not to sue GRACE Co-op, GRACE Band, its affiliated clubs, their respective administrators, board members, directors, agents, and other employees of the organization, other members, participants, sponsoring agencies, sponsors, advertisers, owners and lessors of premises used to conduct the event, all of which are hereinafter referred to as "releases," from any and all liability to each of the undersigned, his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury, including death and damage to property, caused or alleged to be caused in whole or in part by the negligence of the releases or otherwise.
5. I acknowledge the contagious nature of the COVID-19 "Coronavirus."
6. I am familiar with the warnings and guidelines of the CDC and of the state of Texas Dept of State Health Services.
7. I understand that attending classes and events that are not socially distanced may increase my risk of exposure to COVID-19.
8. I acknowledge that GRACE Co-op cannot guarantee that I will not become infected with COVID-19 as a result of attending GRACE Co-op or GRACE band classes and events.
9. I understand that the risk of becoming exposed to and/or infected by the COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, GRACE Co-op or band members and their families, church staff, church volunteers, and other organizations who use facilities rented by GRACE Co-op.
10. I understand and agree to abide by the COVID-19 policies put out by GRACE Co-op and GRACE Band. I understand these policies may be changed as government mandates change.
11. I understand that at this time there is no way that GRACE Co-op or GRACE Band can guarantee that I or any of my family members will not come in contact with someone who may have COVID-19.
12. I hereby release and agree to hold GRACE Co-op, the GRACE Co-op board of directors, the band director, Grace Bible Church, Crestview Baptist Church, St. John's United Methodist Church or any facility hosting GRACE events or classes harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act, or that may otherwise arise in any way in connection with GRACE Co-op.
13. I understand that this release discharges GRACE Co-op, GRACE Band, Grace Bible Church, Crestview Baptist Church, St. John's United Methodist Church or any facility hosting GRACE events or classes from any liability or claim that I, my heirs, or any personal representatives may have against the organization with respect to any bodily injury, illness, death, medical treatment), or property damage that may arise from, or in connection to, any services received from GRACE Co-op. This liability waiver and release extends to GRACE Co-op and their host facilities together with all owners, partners, employees, volunteers, before, during, and after the classes and events.
