

Christian Homeschoolers of Fountain Hills, CHFH: INSURANCE WAIVER AND RELEASE OF LIABILITY

In consideration of being allowed to participate in any way in Christian Homeschoolers of Fountain Hills related events and activities, the undersigned:

1. Agree that as a participant and parent(s) and/or legal guardian(s) of the participant(s) he/she will inspect the facilities and equipment to be used, and if the participant believes anything is unsafe, he or she should immediately advise supervisor (advisor, manager, etc.) of such condition(s) and refuse to participate.
2. Acknowledge and fully understand that each member/participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their actions, inactions, or negligence but the action, inaction, and negligence of others, or the condition of the premises or of any equipment used.
3. Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.
4. INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in activity, whether caused by the negligence of release or otherwise. The undersigned acknowledge that CHFH and their directors, officers, volunteers, representatives, facilitators and agents are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting an activity on their behalf.
5. Release, waive, discharge and covenant not to sue Christian Homeschoolers of Fountain Hills, its affiliated clubs, their respective administrators, directors, agents, and other employees of the organization, other members/participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event, all of which are hereinafter referred to as "releases," from any and all liability to each of the undersigned, his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury, including death and damage to property, caused or alleged to be caused in whole or in part by the negligence of the releases or otherwise.
6. Any legal action taken in disagreement with the above statement is an automatic forfeit, dismissal, and revocation of membership as is any lack to comply with the Conflict Resolution Article as stated in Christian Homeschoolers of Fountain Hills bylaws.
