

2022/23 LEARN Waiver of Liability

The novel coronavirus (“COVID-19”) has been declared a worldwide pandemic by the World Health Organization. COVID-19 is predominantly a respiratory illness that can affect other organs. People with COVID-19 have had a wide range of symptoms reported, ranging from mild symptoms to severe illness. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact and through aerosol droplets. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing, vaccination, and masking when social distancing is not possible.

LEARN has put in place preventative measures to reduce the spread of COVID-19; however, we cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending LEARN activities could increase your child(ren)’s or your risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending LEARN activities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at LEARN activities may result from the actions, omissions, or negligence of myself and others, including, but not limited to, LEARN volunteers, member families, and non-member participants.

I further agree that if any of my family members/participating guests or I are feeling ill, have symptoms of COVID-19, or have a suspected or confirmed case of COVID-19, we will not attend LEARN activities. I understand that as a member family it is my responsibility and obligation to adequately communicate the requirements identified herein to my guests. I further understand that as a member parent/guardian it is my obligation to enforce these requirements with respect to my family and guests; and further, the refusal or failure to adhere to any of these requirements by me or any of my guests shall be grounds for the expulsion of said person(s) from the activities without refund and/or the immediate and early termination of my membership without refund.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with participation in LEARN activities (“Claims”). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless LEARN, its Board, and its volunteers (current and future) of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of LEARN, its Board, and its volunteers, whether a COVID-19 infection occurs before, during, or after participation in any LEARN activity.
