I, the undersigned ("Releaser"), hereby make application for membership in Cornerstone Christian Home Educators (CCHE). I understand and support the purpose of CCHE, which is: 1) to represent the homeschool community in a manner that honors Jesus Christ; 2) to provide support for homeschooling parents/guardians; 3) to keep the group informed of any pertinent homeschool current events such as seminars, conferences, and legal issues; and 4) to create opportunities for group activities.

Upon acceptance, I sincerely pledge to obey and uphold all rules and regulations of CCHE, which are set up for the purpose of keeping order and for the protection of participants from injury. In consideration of being permitted to participate in CCHE activities, including but not limited to attending classes, group activities, play dates, field trips or participation in any way, the undersigned, for himself/herself, any personal representatives, heirs and next of kin, hereby acknowledges, agrees and represents the following:

- The undersigned hereby release, waive, discharge and covenant not to sue CCHE, its board members, members, instructors and authorized guest instructor(s) (hereinafter referred to as the "Releasees") from liability to the undersigned, his/her personal representatives, assigns, heirs and next of kin for any loss, damage, and any claim or demands therefore on account of injury to the person or property or resulting in injury or death of the Releaser, whether caused by the negligence of the Releasees or otherwise while the Releaser is participating in any of CCHE activities;
- The Releaser hereby assumes full responsibility for any risk of illness, bodily injury, death, or property damage due to the negligence of the Releasee or otherwise while participating in any of CCHE activities;
- The Releaser also releases Okeechobee Church of God and Big Lake Baptist Association, whose facilities are used, from all liability claims, judgments or demands from damages arising from accidents, injuries or illness of the Releaser and family, whether caused by the negligence of the facility owner/operator or otherwise while the undersigned is in, upon, or about the premises or any facilities therein where CCHE activities are ongoing;
- The Releaser hereby acknowledges that he/she has medical insurance or is self-insured and does not and will not expect CCHE to pay for any medical bills or any expenses of any kind as a result of the Releaser participation in any CCHE activity; and
- The Releaser hereby acknowledges that their participation in any CCHE activity is on a voluntary basis and no promises or guarantees have been made to the undersigned Releaser. If the participant is a minor, the Releaser agrees that the minor has the Releaser's consent to participate in whichever activities the Releaser chooses. The Releaser further provides consent to CCHE to seek emergency treatment for the minor, if necessary. The Releaser agrees to accept financial responsibilities for the costs related to this emergency treatment.

The undersigned further expressly agrees that the foregoing Release and Waiver of Liability Agreement is intended to be a broad and as inclusive as permitted by the laws of the State of Florida and if that any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force in effect. The undersigned has read and voluntarily signs this Release and Waiver of Liability Agreement and further agrees that no oral representations, statements or inducement apart from the foregoing written agreement have been made.
