Our Facility

Thrive rents space from Beach Chapel and St. Marks in Encinitas on Mondays and Wednesdays. These churches have a heart for kids and the community! They have partnered with us to offer an alternative educational program for children throughout north county and we are so thankful! We highly encourage you to discover all of the ministries they have available for your family. Ministries are available for the entire family ranging from prayer to preschool! *For all Thrive related questions please contact a Thrive team member and not the church staff.*

Disclaimer: We have been made aware and want to inform you that there are cell towers on and or near the church facilities that we are renting space from and they have been here for over 20+ years.

Community Dynamics

Thrive partners with homeschool families. One of the qualities that makes Thrive unique is the opportunity we have to apply best practices to deeply impact and maximize the overall education of our children. Students are on campus 1 or 2 days a week which allows for several opportunities for small group interaction outside of class. Being off campus more days than on creates an environment where the child is eager to come to the THRIVE Community Program as well as our preferred vendors. Time with peers and teachers is greatly appreciated and valued not only by the student but by the family. All courses, with the exception of a few, have mixed ages. There is much research to support why this kind of educational structure sets students up for more success when entering young adulthood. We at Thrive are able to see it first hand as the older students become leaders and the younger ones become more confident by being mentored. It is not unusual to find siblings in classes together and eating lunch together. This model fosters a love of lifelong family relationships and respect for each other.

Fees & Fundraising

Fees

In our model, parents pay the teacher directly for each class they enroll in and then the teacher pays a corresponding rental fee to Thrive to cover our administrative and operating costs. Families also pay an affordable registration fee to Thrive (per child) to access all of our class offerings each semester (similar to paying for a Costco membership). This fee structure constitutes the bulk of Thrive's program revenue and provides us with the necessary financial stability/resources so we can focus on offering a top notch educational experience to our families.

In terms of the financial benefit to our families, paying a simple and affordable registration fee is a big win as there is no fixed annual tuition fee that they must pay upfront, but instead they simply pay for what they actually participate in. Ultimately, this means that families pay significantly less than they would if they were attending a traditional private school and are getting a tailored education for their child since the classes are personally selected by them.

Fundraising

Thrive runs fundraising campaigns each semester to supplement program revenue and provide us with scholarship funds to distribute to our families in need. Making the program accessible to as many families as possible (regardless of financial status) is a huge part of our mission and vision. This current school year alone we have been able to offer \$100,000 in scholarships (which serve 20 refugee children, single moms, families in ministry and families in crisis) and also fund a full time armed security guard (through Off Duty Officers) This couldn't be done without the <u>extreme generosity</u> of our parent and donor base who share the same passion to see this program touch as many lives as possible. Family Commitments

Vendor Fees

Vendors/Program-Providers each run their own businesses and are not under Thrive as an entity. Any course you enroll in allows you to work directly with each vendor/program-provider. You will be able to establish a relationship with the vendors and can contact them directly for any needed communication. You will not need to contact Thrive for communication intended for a vendor as each one operates independently.

Payment is made to vendors directly by whatever means they accept. At Thrive we have a culture of honor and as such hope that all families will honor their financial commitments in a timely manner. Our vendors are accommodating and usually offer monthly payment plans through PayPal, Venmo, Zelle. or other convenient payment systems. *Registering for a vendor class means you are committing to their financial requirements. If you are unsure if you want to be financially responsible for a class you should wait to commit until you are certain or communicate directly with the vendor so they understand your specific situation. Defaulting on payments or refusal to pay Vendors in a timely manner could jeapordize a families membership with Thrive.*

Membership Fee

We desire every member of our Thrive community to value the culture as much as we do! We believe in complete transparency and want you to know what your membership fee supports.

The fun stuff - Access to a THRIVING community of homeschool families, special events and special guests, celebrations, monthly chapel, up to 6.5 hours of supervision, drop-off program, lunch and recess on campus, study hall with volunteer tutoring, highly qualified program providers at the same location and so much more!

The boring stuff - Insurance, legal fees, technology fees, facilities, cleaning, supplies, administrative and operational costs, and so much more!

<u>Thrive fees are charged *per semester*</u>. The cost for **Fall 2023 semester is \$175 for a single child family membership and \$50 for each additional child up to a \$275 maximum per** family membership. You will have access to our amazing community program once you have paid your semester dues. All dues will be collected prior to the start of the semester.

Lunch and Study Hall are add-ons to the Thrive Community Program. If you sign up for these, you will be invoiced **\$20 for 16 weeks of lunch and \$20 for 16 weeks of study hall per semester**. (One study hall per student per day).

Community Hours

This is a huge reason why our culture is Thriving! Thrive values our culture of family involvement and sees our parents as the core to their children's education. It is in partnership with our families that we are able to offer our program. As part of the Thrive Community **Program, each Thrive family is required to serve 13 hours on campus each semester.** There are a variety of opportunities from playing soccer with kids during lunch, to helping kids with tough math problems, to smiling and greeting our families at check in and check out. Whatever your strengths, we have an opportunity for you! You will be able to sign up for days/times/specialties after registration.

Fulfilling these hours helps to ensure the safety of our students on campus and foster a sense of community deepening family relationships. Serving can be fun and a way to connect with other families as well! Many parents offer to serve more than 13 hours because they love being on campus and a part of such an amazing community. You are able to serve one full day and a half or do three 4 hour shifts through the semester. Opportunities for one hour shifts are also available. You are welcome to bring your little ones while you serve as long as you are able to fulfill the task required.

We want to maintain a culture where our kids feel loved and comfortable. When you serve, we would love for you to pour out onto our kids and create an environment for them to THRIVE. Our volunteers deepen the Thrive culture by ensuring aggressive behavior, negative speech or disrespectful behaviors is not tolerated. You will be empowered to kindly correct any students and have them reconcile with their peers. Your love will encourage them to show love and give grace by leading as an example. If there are behavioral issues beyond your abilities, you can always come to our Campus Coordinator at any time to support you. Please familiarize yourself with the Code of Conduct below.

Every parent is responsible to find a replacement for ANY shift they are not able to cover last minute. **If a family is a "no-show" for a shift or doesn't send coverage then they will be charged \$30 per hour missed.**

Conduct Responsibility

Our number one job is to keep students safe while on campus. While doing so, we aim to foster a loving culture of safety, support, joy, encouragement, and kindness. Children are able to flourish when clear boundaries are set while implemented and enforced in a safe and loving environment. In order to maintain a safe environment for all students, disruptive and/or negative behaviors such as bullying, fighting, and disrespectfulness *will not be tolerated*. Thrive seeks to come alongside students and parents helping to guide/partner in a way which leads to restoration and forgiveness. We do this by addressing the inappropriate behavior and encouraging them in better future choices and informing the family. Thrive reserves the right to terminate membership of any student or parent at any time not in support of this policy or by exhibiting a pattern of offensive behaviors or for No Tolerance behaviors.

As a member with us, you will be our torch bearers of this mission as we show a mutual <u>respect to our partners at the churches and the rented spaces we occupy.</u> We know that sometimes things happen that are often out of our control, and as such you will be empowered to rectify any damage or vandalism caused while you or your students are on campus. We will utilize our disciplinary structure listed above to rectify any situation in love. We will be sure that any financial responsibility or other reconciliation to the property is negotiated with you directly to ensure everything is left better than we found it! We are so grateful to have our amazing partners at Beach Chapel & St. Marks renting us their beautiful space and, per our lease, each member will be expected to ensure the campus is given the utmost respect and care while we are there.

Policies and Procedures

Identification Policy

Safety is so important to us as we seek to provide a joy-filled atmosphere to our children. With that in mind, we require all adult members to show identification while on campus. Parents are required to wear a TLC photo ID badge anytime while on campus. The front desk monitors will be checking badges during student drop off and pick up. If someone other than the parent is dropping off or picking up a child, this person will need to show the parent's badge. Only one badge is required per family. Vendors are required to wear their photo ID badge while on campus. Any campus visitors will need to first check in with the front desk monitor and will be required to wear a visitor badge while on campus. You can purchase your photo ID badge <u>here</u>.

Children grades K-3 will be required to wear a green lanyard while on campus at all times with their course schedule attached to it. You can find the schedule template to print out on our website or by clicking <u>here</u>. Please print it, fill out your K-3rd graders schedule, and place it in the clear schedule holder. You can purchase the lanyard and holder <u>here</u>.

Electronics Policy

NO CELL PHONES ALLOWED ON CAMPUS EXCEPT: We allow electronics on campus under the following guidelines:

1) Parent Communication: A phone or device necessary for contacting parents and/or guardians. Devices need to be kept in backpacks at all times and only taken out for

immediate use with vendor/staff approval. No devices will be allowed in bathrooms or private places.

 Educational Purposes: A computer or ipad may be needed for homework during study hall or for a class requiring it. In class, the vendor will be responsible for monitoring screen activity. Study hall monitors will supervise devices used for educational purposes only.

No devices are allowed on the playground or during lunch. We reserve the right to confiscate any electronic devices not being used per our policy and to dismiss any member without a refund who refuses to adhere to the aforementioned policy. All confiscated electronic devices will need to be picked up in person with the Program Director. allison@thrivelearningcenter.org

Sick Policy

If your child is ill, please keep them home. If a child has a fever, green mucus, a persistent cough, stomach ache, stomach flu, or diarrhea we will ask the parent to pick them up. Please make sure that your child is <u>free of all symptoms and fever for a minimum of 24 hours</u> before returning to campus.

Lice Policy

Please notify the Campus Coordinator immediately if your child has lice so we can notify our members. The quicker lice can be identified, the easier it is to manage. Please keep your child home if they have lice. Vendors will be notified so that families can be contacted letting them know their child might have had exposure to lice and to inspect their children. After the second application or official recheck of the lice treatment, the child can return to the program. The identity of the infected child will not be shared.

Dress Code

When attending Thrive's on or off campus events and programs, please ensure your attire is appropriate to distraction-free learning. We reserve the right to send children home who are dressed in inappropriate or distracting clothing such as revealing midriff, mini skirts, clothes revealing too much skin, displaying derogatory language or pictures etc. Thank you for partnering with us to create a healthy environment for our students.

Special Needs/Allergy Policy

Please contact the campus director if you have a child with medical or behavioral needs that require special accommodation. Thrive seeks to meet the needs of all families and will do its best to accommodate all students. Thrive asks all vendors to not use any peanut products in their classes.

Lunch, Study Hall

Lunch and Study Hall are Thrive Community Program supervised periods. A small fee covers the space and costs associated with meeting the needs during these times. If your student will attend Lunch or Study Hall they will need to be enrolled prior to attending.

*Study hall is limited to one period per day and <u>does not accommodate Kindergarteners through</u> <u>2nd graders.</u> This time is most effective for responsible students grades 3rd and up. Please make sure that any student attending study hall has an hour's worth of work and assignments to complete. There will be study hall monitors to monitor behavior but not able to give individualized instruction.

Vendor Assistant Policy
