## **CHE Fact Sheet**

### **Who is Christian Home Educators?**

CHE is a support group for home school families that offers connection with other home educators for various activities throughout the year.

### **How do I become a member?**

This packet contains an Application for Membership that must be completed and submitted to the CHE Board of Directors for consideration. Upon receipt of your application you will be notified of the date of the next board meeting where it will be reviewed. After consideration by the Board, you will be contacted by a board member with information about membership.

### **How much does it cost to join CHE?**

\$65 annually. This includes access to our website and a full-color yearbook.

### **What is Co-Op?**

Co-Op is short for Cooperative Learning Day. Participating CHE members and children meet on Mondays in the fall and spring for various classes and fellowship opportunities. A parent from each participating family must volunteer to help in Co-Op by teaching or assisting in a class or working in the nursery. **Co-Op requires a separate registration each semester. The Co-op participation on-line sign-up link will be posted through the website email forum on July 1 for the fall semester and December 1 for the spring semester. This link clearly state deadlines, dues and other pertinent information about Co-Op.**

### **How much does Co-Op cost?**

There is a \$5.00 registration fee per family to cover the cost of copies, mailings, etc. Additionally, \$5.00 per child per class is charged to cover the cost of teaching materials and other items. The family maximum is \$35.00 per semester. (For example, a family with one participating child taking three classes would pay \$20.00, but a family with four participating children all taking three classes would only pay \$35.00 per semester.) Some classes may have extra fees. These are stated in each semester's registration packet.

# Constitution of the Northeast Arkansas Christian Home Educators

## **Article 1: Description / Mission Statement**

The Northeast Arkansas Christian Home Educators (CHE) exists to support and encourage families who have chosen to educate their children at home from a distinctly Christian perspective. We do so in part by providing student activities, corporate educational opportunities and forums designed to encourage those facing the practical challenges of home education. Additionally, we seek to raise awareness of legal and political issues affecting home educators. Our hope is that as iron sharpens iron, we will sharpen one another for the task of raising and educating our children to live for the glory of God.

## **Article 2: Government**

CHE shall be governed by a Board of Directors composed of eight to twelve members. The Board of Directors is responsible for oversight of all business affairs engaged in by CHE; review and acceptance or denial of all applications for membership, and the calling of all Business Meetings. Board meetings require at least 50% attendance to comprise a quorum.

Members of the Board of Directors are elected to serve a two year term with only six of the twelve Board positions being voted on at the Annual Meeting held each year between April 15 and May 15. If a current Board member declines to complete the second year of his term on the Board that position may be filled through election at the Annual Meeting as well. Board members are automatically nominated for re-election unless they revoke such nomination.

All other nominations for service on the Board must be submitted in writing to the current Board President at least one week prior to the Annual Meeting. Nominees must be fathers who have been members of CHE for a minimum of twelve months. All qualified nominees shall be presented to the CHE membership on an official ballot at the Annual Meeting. A simple majority vote of all ballots received is required for election to the board. Board members lost by attrition may be replaced by the Board or Directors. If the number of Board members drops below six, the vacancies shall be filled at a Business Meeting of the CHE membership called by the remaining board members.

The date, time and location of the Annual Meeting and any special called Business Meetings shall be announced by the Board of Directors to the CHE membership at least two weeks prior to meeting date. Any proposed revisions to the Constitution shall be provided in writing to the CHE membership by the Board of Directors at least one month prior to presentation at a special Business Meeting or Annual Meeting. The members present at the special Business Meeting or Annual Meeting shall constitute a quorum.

Officers of the Board of Directors are President, Vice-President, Secretary and Treasurer. Officers shall be elected by the Board within three weeks of the Annual Meeting. Board officers shall be announced to the CHE membership in the first newsletter following election.

## **Article 3: Membership**

The membership of CHE shall be comprised of home schooling parents who are committed followers of Jesus Christ and active participants in a local church. All applicants for membership must receive a 100% affirmative vote by the Board of Directors before membership is conferred.

Applicants for membership must provide the Board of Directors a completed CHE application and a letter of recommendation from their Pastor or other person approved by the Board.

Membership for parents living together is contingent upon marriage. CHE defines marriage as the legal union of a man and woman as husband and wife.

The Board of Directors reserves the right to dismiss any member(s) from the Association on a simple majority vote. The member(s) in question has the right to a hearing before the Board.

#### **Article 4: Statement of Faith**

We believe the Bible to be the inspired Word of God, the final authority of faith and life, without error in its original writing both in doctrine and historical details, and that all true knowledge is consistent with its revelation.

We believe that there is one self-existent God who has always been and will always be, manifest in three persons, Father, Son and Holy Spirit, and that knowing Him truly is the foundation of all knowledge, wisdom and understanding.

We believe that Jesus Christ is the Son of God manifest in the flesh, born of a virgin, that He is the Savior of mankind through His death on the cross, that He rose from the dead and ascended to God, and that He will return again and will raise those who have believed in Him to reign with Him in power and glory throughout all eternity.

We believe in the brotherhood of all believers who, through faith, have received the salvation provided by God's grace through the death of Jesus Christ.

We believe that children belong to God who has given the responsibility and authority for their education to their parents and that it is their responsibility to protect this parental right.

# 2017-2018 CHE Policies

Every member of CHE plays a vital role in the success of our group. Members are expected to conduct themselves in a Christ-like manner and encourage one another to strive for excellence in educating our children. The following policies provide guidelines for specific activities of CHE and instructions for certain issues that may arise. Should you need more information about activities, please contact the committee chairperson, the MAC president or the Board president.

**1. Family Fellowships and Programs** – Open to CHE Member families and their invited guests.

**2. Field Trips, Children's Parties, & Special Events** – All **Children's Parties** are open to the children of CHE Member families who have met the requirements set for that event (such as age, fee, sign-up, etc.). No guests are allowed. **Field Trips** are open to CHE Member families and their guests. All guests must be accompanied by the CHE parent who has invited them. That parent will be responsible for the guest throughout the entire event.

**3. Teen Night** – Teen nights are only open to CHE members' 7<sup>th</sup>-12<sup>th</sup> grade children (no guests or visitors) who are currently being homeschooled and who have met the requirements set for that event (age, fee, sign-up, etc.). Older or younger siblings of 7<sup>th</sup>-12<sup>th</sup> grade students may attend Teen Nights if necessary but may not participate in Teen Night activities.

**4. Sports Teams** – Only open to CHE member children who are currently being home schooled and have met all the requirements for the team (such as age, fees, etc.).

**5. MOMS Meetings** – Open to all CHE Mothers and their invited female guests.

**6. Cooperative Learning Day (CO-OP)** – Only open to the children of CHE member families who are currently being home schooled and who have met all the requirements for participation in CO-OP (deadlines, forms submitted, fees paid, parent participation, etc.). To be eligible for the fall semester, a family must have been approved for CHE membership prior to July 1st of that year. To be eligible for the spring semester, a family must have been approved for membership prior to December 1st of the preceding year.

**7. CHE Board Meetings** – Open to current Board Members and any invited guests. Any CHE member may attend the first 30 minutes of a scheduled meeting to bring a matter before the Board.

**8. Graduation** – Participation in the ceremony is open to CHE member children who have met requirements set for that event. Observing the ceremony is open to all CHE members and their invited guests.

**9. Yearbook** – Each family is provided one copy of the yearbook and is strongly encouraged to submit family and individual children photographs to the Yearbook Committee by the announced deadlines. Participation on the Yearbook Staff is limited to qualifying CHE members.

**10. Fundraisers** – All fundraising activities must be approved by the Board. Members should submit a written explanation of the fundraiser, including- what it will be, what it will finance, who will be in charge, and who will be expected to participate in the actual fundraising to the Board. If the fundraiser is fronted by CHE, monies are to be turned into the treasurer along with a recap of expenses and all receipts.

**11. Board Members** – Open to any man who has been a member of CHE for at least one year. His nomination must be in writing by a current member of CHE. A short biography should be submitted to the president at least one week prior to the Annual Meeting when Board members are elected. Each board member is elected to a two-year term, and is automatically re-nominated unless he revokes his nomination.

**12. Conflict Resolution** - The proper process for handling conflict within CHE, whether between individuals, families or an individual and a committee shall be as follows: A) The offended party should speak privately to the offender, or in the case of a committee they shall speak to the committee chairperson and seek to resolve the issue. B) If no resolution can be reached by personal interaction, the offended party may submit a letter to the CHE Board president detailing the incident and their concerns. The letter should be limited to

personally observed facts and avoid ascribing motives or discussing personality and/or character issues. While awaiting the action of the Board, all parties should seek to keep the matter private and not engage in discussions regarding the conflict. C) The president will bring the matter before the Board at the next regularly scheduled meeting or via email if the meeting is more than one week away. D) Board representatives will be chosen to arrange a meeting with all parties involved in the conflict. If the person who wrote the letter refuses to attend, the matter will be dropped. After meeting with all involved parties, the Board representatives will take the matter back to the Board who shall then determine a course of action. All parties involved will be notified of the Board's decision by the representatives or a Board officer within one week. If it becomes evident that a member of CHE (be it the offended party, the offender or any other members) is stirring up dissension within the group by broadcasting information about a conflict, the matter will be addressed by the Board and that member and their family may be removed from membership within CHE.

**13. Sexual Immorality** - If it becomes evident that a student participating in CHE is involved in sexual immorality or becomes pregnant the following actions will be taken: 1) If a pregnancy is involved, the Board will seek to determine the nature of the pregnancy: if it is the result of rape the Board will work with the student to help continue their involvement with CHE. 2) If it is clearly determined that a student has been participating in sexual immorality (either evidenced by a pregnancy or confession), the student will be suspended from all closed CHE activities (activities that only CHE students may attend, i.e.: Co-op, Teen Nights, Spring Formal, etc.) for one year. After the one year suspension, the student and their parents may petition the Board for reinstatement to closed CHE activities. The Board will seek to determine at that time if the student has rejected a lifestyle of sexual immorality. If the student has not come to a point of rejecting that kind of lifestyle, he or she will not be allowed to participate in closed CHE activities. If a student has a second offense after being reinstated to CHE activities, they will be suspended permanently. 3) This policy is in effect for both girls and boys who are clearly involved in sexual immorality.

## 2017-2018 CHE Fees

**Annual Dues** - \$65 per family per year. This amount is due by June 25<sup>th</sup> each year. If dues are not received by June 30<sup>th</sup> former members will have to reapply for CHE membership and Fall Co-Op will be closed for that family. Dues include access to the member's area of our webpage and one copy of our full color yearbook.

**Cooperative Learning Day (Co-Op)** - There is a \$5.00 registration fee per family to cover the cost of copies, etc. Then the cost is \$5.00 per child per class (to cover teaching materials, etc.) with a total family maximum of \$35.00 per semester. For example, it costs one child \$20 to take three classes (three classes (\$15) plus the registration fee (\$5)), however if you have a family with four children it would cost \$35 per semester due to the maximum. The maximum cost is calculated each semester based on a family with two students participating in classes each hour. There are scholarships available with a written request.
