For and in consideration of permitting members of the _____ Family to engage in and/or receive instruction in any activity sponsored by SEEDS OF PROMISE FSG, the undersigned parent(s) and/or guardian(s) hereby voluntarily and absolutely release, discharges, waives, and relinquishes any and all loss or damages or action or causes of action for personal injury, property damage, or wrongful death as a result of his or her observing or using facilities of equipment sponsored by SEEDS OF PROMISE FSG, or engaging in or receiving instructions in any activities or in activities incidental thereto wherever however the same may occur, and for whatever period said activities or instructions may continue.

3. NO DISRESPECTFUL OR ROWDY BEHAVIOR
4. NO 'FAILURE TO SHOW' AT RESERVED FIELD TRIPS

**Cancellation and refund policy will be established on a trip-by-trip basis. Failure to abide by the above standards will result in the following:*

- 1st offense: Discussion
- 2nd offense: Warning
- 3rd offense: Restrictions from field trips or Seeds of Promise FSG activities for remainder of school year.

2. NOTICE OF RELEASE OF LIABILITY

Field trips, co-op, events, meetings and activities for the Seeds of Promise Family Support Group are planned and organized by volunteer members of our group. Most events are advertised in our monthly newsletter. If you wish to participate in an event, you will be assuming all risks, if any, for your participants as the Seeds of Promise FSG does not carry event insurance. Each parent is responsible and liable for their family's transportation to and from events. Parents are also responsible for monitoring their children's behavior on events. Please consider the activities involved in each event and the suggested age level. If you feel that your child will not be able to safely handle an aspect of the field trip activity, you should remove your child from participating in the event. Each participant must assume the risk of physical injury, wrongful death, property damage that could result from any of these activities and events.

3. PHOTOGRAPHS

I understand that by becoming a member of the Seeds of Promise Family Support Group I give my permission that any photos taken of me or my children at Seeds of Promise FSG events or field trips may be used on the Seeds of Promise FSG website (www.seedsofpromisefsg.com) in the Members' Only section. If I object to this, I will advise the Seeds of Promise FSG in writing.

4. WEBSITE PASSWORD
