If, after thoroughly reading the enclosed information and considering this matter in prayer, you decide to apply for this program, the procedure is as follows:

- 1) Fill out the Family Application Form. Make sure you write out your reasons for homeschooling.
- 2) Read and sign the Philosophy of Home Education, Parental Requirements & Responsibilities Statement.
- 3) Read and sign the Statement of Faith. Please check only one box on this form.
- 4) Both parents must sign all forms if applicable.
- 5) Submit a copy of your high school student's transcript for completed 9th and/or 10th grades (if applicable). We do not accept seniors into our program.
- 6) Return completed Family Application Packet via email to psp@fremontchristian.com along with a non-refundable application fee of \$40 sent to:

Upon receiving your completed application, you will be contacted within 10 business days. A 20-30 minute phone call interview will be scheduled. Upon completion of the interview/phone call, you will be directed to the enrollment paperwork and procedures.

Enrollment in this program is subject to space availability. Please make sure your packet is filled out completely and signed by both parents. An incomplete packet will be returned to you, causing a delay in your application process.

The process to secure all necessary documentation may take several weeks, so please plan accordingly so all paperwork and fees are received by the above deadline.



Fremont Christian School's Private Satellite Program upholds the following Philosophy of Home Education:

- We believe that children are a gift from God. (Psalm 127)
- We believe that God has equipped the parents to "train up a child in the way he should go." (Proverbs 22:6)
- We believe the responsibility for education rests upon the parent. (Ephesians. 6:4)
- We believe that parents, under the direction of the Lord, possess the wisdom, knowledge and understanding to successfully educate their children. (James 1:5)
- We believe that God uniquely designs each family, and thus, no two home educational environments are identical. (1 Corinthians 12:4-11)
- We believe that not only is it the parents' God given duty to diligently teach, nurture, and direct their children (Deuteronomy 6:5-7), but it is also their constitutional right.

FCS PSP is a Christian ministry. We are here to support, assist, guide, and help make accountable those families who have accepted the challenge of home educating their children through Fremont Christian School.

PARENTAL REQUIREMENTS AND RESPONSIBILITIES

FREMONT CHRISTIAN SCHOOL STATEMENT OF FAITH

All personnel of Fremont Christian School are asked to read the following Statement of Faith, which is the doctrinal basis for all our religious teaching.

Fremont Christian School is owned and operated by Harbor Light Church, an Assembly of God Church, and is interdenominational in its attitude and ephansis. Both the church and the school stand firmly on the changeless Word of God as expressed in the following statement of historic evangelical Christianity.

ACSI Statement of Faith

- We believe the Bible to be the inspired, the only infallible, authoritative, inerrant Word of God (2 Timothy 3:16, 2 Peter 1:21).
- We believe there is one God, eternally existent in three persons Father, Son, and Holy Spirit (Genesis 1:1, Matthew 28:19, John 10:30).
 We believe in the deity of Christ (John 10:33), His virgin birth (Isaiah 7:14, Matthew 1:23, Luke 1:35), His sinless life (Hebrews 4:15,
- We believe in the delay of christ (John 10.33), his virgin birth (Isalah 7.14, Matthew 1.23, Luke 1.35), his sinless me (Hebrews 4.15, Hebrews 7:26), His miracles (John 2:11), His vicarious and atoning death (1 Corinthians 15:3, Ephesians 1:7, Hebrews 2:9), His resurrection (John 11:25, 1 Corinthians 15:4), His ascension to the right hand of the Father (Mark 16:19), and His personal return in power and glory (Acts 1:11, Revelation 19:11).
- We believe in the absolute necessity of regeneration by the Holy Spirit for salvation because of the exceeding sinfulness of human nature; and that men are justified on the single ground of faith in the shed blood of Christ and that only by God's grace and through faith alone we are saved (John 3:16-19, John 5:24; Romans 3:23; Romans 5:8–9; Ephesians 2:8–10; Titus 3:5).
- We believe in the resurrection of both the saved and the lost; the saved unto resurrection of life, and the lost unto the resurrection of condemnation (John 5:28–29).
- We believe in the spiritual unity of believers in our Lord Jesus Christ (Romans 8:9, 1 Corinthians 12:12–13, Galatians 3:26–28).
- We believe in the present ministry of the Holy Spirit by whose indwelling the Christian is enabled to live a godly life (I Corinthians 3:16, 6:19–20, Romans 8:13–14, Ephesians 4:30, Ephesians 5:18).
- We believe that the term marriage has only one meaning: the uniting of one man and one woman in a single, exclusive union, as delineated in Scripture (Genesis 2:18–25). We believe that God intends sexual intimacy to occur only between a man and a woman who are married to each other (1 Corinthians 6:18, 7:2–5; Hebrews 13:4). We believe that God's command is that there be no sexual intimacy outside of or apart from marriage between a man and a woman.
- We believe that God wonderfully foreordained and immutably created each person as either male or female in conformity with their biological sex. These two distinct yet complementary genders together reflect the image and nature of God (Genesis 1:26–27).
- Our Statement of Faith is not exhaustive of all of our beliefs. The Bible, as the inspired and infallible Word of God, speaks with absolute authority regarding the proper conduct of mankind and is the unchanging foundation for all belief and behavior. The ACSI Board of Directors holds final interpretive authority on biblical meaning and application with regard to faith, doctrine, policy, practice, and discipline.
