## Code of Conduct

## I. Player Participation Eligibility:

- A. All players must meet the following requirements in order to be eligible for participation on an NEACHE Athletics sponsored team:
  - 1. The player must be home educated a minimum of 51% of school hours, a member of NEACHE during the entire season of the sport activity, and must provide an intent to Homeschool Form for the current school year.
  - 2. The player's age division is determined by his/her age on September 1<sup>st</sup> of the current school year.
  - 3. At least one parent and the student athlete must sign a Parent/Player Contract for each sport in which they will participate.
  - 4. All student athletes must be in satisfactory academic standing and passing all subjects as determined by the teaching parent.
  - 5. Any student athlete found to be engaged in substance use or abuse, as well as any legal/court issues, will be subject to loss of player eligibility.

#### II. Family/Visitors Code of Conduct:

- A. NEACHE Athletics is made possible by the volunteer efforts of NEACHE parents. Your participation as a family is vital to the success of the program.
- B. All family members and visitors are expected to conduct themselves in a Christ-like manner and exercise personal self-discipline, restraint, and genuine kindness toward all others at NEACHE athletic events.
  - All family members and visitors are expected to submit to the authority of the coaches, Athletic Director, Athletic Oversight Committee (AOC), and the NEACHE Board.
- C. All family members are expected to work to promote unity among team members by being an ambassador for Christ, reaching out to those who have needs and treating all members with respect.
- D. In the event of a player or parent issue involving coaches, the coach will be the first point of contact and the Athletic Director will be the second. There will be a 24 hour "cooling off "period before addressing coaches following a game. The Athletic Director will not consider any issues from parents or players that concern the amount of playing time that a player receives while being coached. If the matter or issue cannot be satisfactorily handled by the Athletic Director, then the issue would be reviewed and handled by the AOC. All issues sent to the AOC must be in writing via email or letter not by text message or via phone. All issues that cannot be resolved by the AOC will be sent to the CHE Board of Directors.
- E. Discipline / Suspension: By signing the contract below, players, parents, and coaches agree to comply with the NEACHE Code of Conduct (which is outlined in this document). Any violations to the Code of Conduct will result in either the coach, the NEACHE AOC, and/or the NEACHE Board taking appropriate disciplinary action. Appropriate disciplinary action can and will include suspension frompractices, games, and/or the athletic season.

#### III. Family Participation Guidelines:

- A. Team participation fees and travel expenses are the sole responsibility of the participating family.
- B. Any fund raising activity by parents or players of a team must have prior approval by the NEACHE AOC.
- C. Treatment of gymnasiums secured by NEACHE Athletics will be in accordance with that gym's existing rules (ex. where to sit, where food is allowed, where children may play). Siblings of participating players may not be left unattended at gymnasiums which NEACHE Athletics has secured for the purpose of practices or games. Families or individuals remaining in any gym during NEACHE team practices are asked to keep noise levels and activity at a minimum.

# Athletics Contract

# I. Player Contract;

I make the following the commitments to my Lord, my parents, my coaches, my team, and myself.

- 5. I will pay my registration and uniform fee at the deadline given by the Athletic Director.

## II. Parent Contract:

I will do my best not to criticize, complain, or in any way undermine the leadership position that God has given them.

- 2. I will subject myself to the authorities that God has placed in my life, including my church family, the NEACHE Board, AOC committee, and game officials.
