**Tuition Options (Select one):**

**Monthly Tuition:** Assessed over 10 equal payments (August - May). The first payment is due on **August 7, 2026**; all subsequent payments are due the first Friday of the month.

**Yearly Tuition:** Receive a 10% discount when the full year of tuition is paid by **August 7, 2026**. Tuition is forfeited with early withdrawal.

**Re-enrollment Forms:** All forms are located on the website each Spring. You must complete the Annual Agreements and Academy Day Contract (if applicable). You must also update your Family Profile, and pay the re-enrollment fee for re-enrollment to be considered complete.

**Home School Legal Defense Association:** Annual membership is required for all families. A discount is applied when you use the SBFA group membership code: 288003. Your HSLDA annual membership is due upon renewal date. HSLDA should send a renewal notice to your email address, with directions to pay online. ([www.hsllda.org](http://www.hsllda.org)) **Loss of HSLDA membership will result in disenrollment from SBFA.**

**Tuition and Academic Forms** are due on the 1<sup>st</sup> Friday of each month and are considered late if not received in the office by the following Tuesday (i.e., Course of Study, Report Cards, Parent Ed). These forms may be emailed to [SBFAforms@sbfaithacademy.org](mailto:SBFAforms@sbfaithacademy.org), mailed, or brought into the school office. See Annual School Calendar or Newsletter for specific due dates for all forms.

**Late Fees** will be incurred for items turned in after the Tuesday following the due date. (Waivers will not be given.)

**Summary of SBFA Delinquency Procedures**

An automatic late fee will be charged if tuition and paperwork are not received by the Tuesday following the Due Date. Waivers will not be given. If all tuition, forms, and late fees are not received by the last day of the month, the family may be subject to immediate disenrollment. Re-enrollment will require new registration fees, paperwork, and payment of all late fees. If you have extreme financial hardship, please submit a request in writing to the School Board prior to the Due Date.

\*SBFA reserves the right to adjust tuition and fees as needed on an annual basis to account for operational needs. Families will receive written notice of any adjustments.
