I ASSUME ALL RISKS OF INJURY TO PERSON AND PROPERTY, WHICH MY CHILD(REN), GUESTS OF MY FAMILY, GRANDPARENTS, RELATIVES, SPOUSE, OR MYSELF SUFFER OR CAUSE IN CONNECTION WITH ANY HBHE ACTIVITY OR PROGRAM, AND WILL NOT HOLD HBHE AND ITS OFFICERS, REPRESENTATIVES AND EVENT LOCATIONS* RESPONSIBLE OR LIABLE IN THE EVENT OF SUCH INJURY.
