## **JUBILEE Christian Homeschool Families Waiver Release**

In consideration of being invited to participate in any sport, class, field trip, or any other activity organized by the JUBILEE or its coordinators, members, and all other persons or any and all entities acting for them, I hereby acknowledge, agree to and accept on behalf of myself, my children, parents, heirs, assigns, personal representative and estate to the following:

I acknowledge that any sport or activity involves known and unanticipated risks which could result in physical or emotional injury, disability, death, and property damage. I understand that risks cannot be completely eliminated when involved in an activity without jeopardizing the essential purpose of the activity.

My participation or my children's individual or collective participation in any activity scheduled through JUBILEE is completely voluntary. I expressly accept and assume any inherent risks in any activity sponsored or organized by JUBILEE coordinators, members, and associates. If at any time I believe that any event conditions are not safe or one of my family members is unable to participate because of a physical or medical conditions, I will immediately discontinue participation until I believe the event's safety conditions are improved and/or the participant's physical or medical condition has improved to the point of safely participating in the event.

I represent that I, or my family members, do not have a medical or physical condition that could interfere with my safety or my family members' safety while participating in an JUBILEE activity, or I will assume and bear the costs of all risks that may be created both directly or indirectly by any such condition.

I have adequate insurance to cover injuries, illness, or damage that I or my family members may suffer while participating in any activity organized by JUBILEE or its members, or I agree that my family and I will assume and bear any costs of injury, illness, or damage done to myself or my family members.

I hereby voluntarily release, forever discharge and agree to indemnify and hold harmless JUBILEE, the coordinators, members, and associates from any and all claims, demands, or causes of action which are in any way connected with my participation in a sport, class, field trip, or any other activity organized by JUBILEE and the above mentioned individuals. This includes my family members' use of the facilities and equipment arising from negligence. Should JUBILEE or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.

I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

By signing this document, I am affirming my understanding and agreement that if I am injured, or harmed in any manner, my family members are injured, or harmed in any manner or if any of my property is damaged during my participation or my family members' participation in any JUBILEE sport or activity, I may be found to have waived my right and my family members' rights by the court of law to maintain a lawsuit against any JUBILEE coordinators, members, or anyone in contract with JUBILEE Christian Homeschool Families.
