VI. Conduct and Dress Expectations

As we strive to live our lives in a manner pleasing to God and reflect our commitment to Him, we ought to take the time to follow a few simple matters of courtesy. These include issues such as:

- Wearing appropriate attire (modest) to classes and events
 - Shorts, dresses, and skirts must be at least fingertip length or longer when arms are relaxed at the sides and remain decent while being active.
 - No strapless tops
 - No vulgar slogans or images on clothing
 - No bare midriffs
 - No visible piercing rings except on the ears

- Students are NOT allowed to carry weapons on their persons or in vehicles while on campus

VII. Payments

- Registration fees are to be paid directly to CHEC by August 1st. A student's spot in a class is not held until the registration fee has been received.
- All registration fees and supply fees are non-refundable.
- Class fees are to be paid directly to the teacher of each class and are due by the 1st of each month. Payments may be made by check, cash, or the teacher's approved online payment method of the teacher's choice (PayPal, Venmo, etc.) Families may choose to pay monthly, by semester, or for the full year up front.
- If a payment is returned due to insufficient funds, the class fee and any associated bank charges must be paid as soon as possible. Anchor Hall reserves the right to refuse class admittance due to non-payment.
- Payments not received by the 10th of the month may result in a late fee or temporary suspension from class until the balance is paid.
- If a student is removed from a class before the end of the year, whether by Anchor Hall or parental choice, the remaining class fees for the year are still owed, unless the teacher provides a written exception. Failure to pay remaining fees may result in the student being ineligible to register for future classes.
- Class fees are not reduced or refunded for student absences, regardless of reason.

IX. Academic Expectations

Anchor Hall classes are intentionally rigorous and designed to help students grow in skill, discipline, and character. Because we partner with parents in the education of their children, we ask families to support the following expectations:

Student Responsibilities

- Students are expected to complete all assigned work on time and to the best of their ability.
- Students must come to class prepared, with required materials, completed homework, and a readiness to participate.
- Students are expected to demonstrate respectful behavior, attentive listening, and active engagement during instruction and group work.
- Students must take responsibility for missed work due to absences and communicate with teachers as needed.

Homework & Workload

- Because our classes meet only one or two days a week, at-home work is a vital part of the learning process. Homework helps students stay on track, build mastery, and come to class ready to learn and participate.
- Students should expect a consistent weekly workload appropriate to the level of each class.
- Students are responsible for ensuring that homework is completed and submitted according to each teacher's instructions.

Late Work

- Each teacher sets their own late-work policy.
- Students and parents are responsible for knowing and following the expectations for each class.
- Excessive late or missing work may result in a student being removed from the class.

Participation & Effort

- Students are expected to participate fully in class discussions, activities, and group work.
- A pattern of lack of effort, disengagement, or refusal to participate may result in a conference with parents and, if unresolved, removal from the class.

Academic Integrity

- Cheating, plagiarism, copying work, or submitting work that is not the student's own is not permitted.
- Violations of academic integrity may result in a zero on the assignment, parent notification, and possible removal from the class.

Removal for Academic Reasons

- Anchor Hall reserves the right to remove a student from a class if:
 - Assignments are consistently incomplete,
 - The student is not meeting minimum expectations,
 - Behavior disrupts learning, or
 - The student's participation does not align with the academic standards of the class.

Parents will be notified if concerns arise, and teachers will work with families to support student success whenever possible.

X. Attendance & Tardiness

Anchor Hall classes meet only one to two days per week, so consistent attendance is essential for student success and for maintaining the pace of each class. Because we partner with parents in the education of their children, we ask families to support the following expectations:

Attendance

- Students are expected to attend all scheduled class days unless they are ill or have an unavoidable conflict.
- Parents must notify the teacher before class if a student will be absent.
- Students are responsible for completing all missed work and for staying on pace with the class.
- Excessive absences may result in a conference with parents and, if unresolved, removal from the class.

Tardiness

- Students should arrive on time, prepared, and ready to begin when class starts.
- Repeated tardiness disrupts instruction and may affect a student's ability to participate fully.
- Chronic lateness may result in a parent conference and could impact continued enrollment in the class.

Late Pickup

- Repeated late student pickups may result in additional fees, parent meetings, and/or review of continued enrollment.

Missed Work

- Students must complete all assignments given during an absence.
- Teachers are not required to reteach missed lessons; students and parents are responsible for catching up using provided materials or instructions.
- Missed classes do not reduce or refund class fees.

Early Dismissal

- If a student needs to leave early, parents should notify the teacher in advance.
- Students are responsible for any work or instruction missed.
