

Application and Registration

• Click on the "Dual Credit Registration" Link at the top of the page.



Students should fill out the application and registration, not parents/guardians.

- If you are new to Concordia Dual Credit, please start with Step 1.
- If you have previously taken CUNE Dual Credit Courses, proceed to Step 2.

Step 1: Online Application (If you have taken CU-DC previously GO TO STEP 2.)

- Again, if you have taken CU-DC previously, please go to STEP 2. The application only needs to be completed once.
- Click on the "Create an Account and Apply Now" button.
- All NEW students must complete the online application by setting up an account with an individual user name and password. **Use a student email, NOT parent/guardian email.**
- Students are STRONGLY encouraged to enter your social security number on the application. This is VERY HELPFUL when requesting transcripts and you will also receive a 1098-T tax form. International students can enter a string of five "1s" to alert the Registrar's office.

Step 2: Online Registration through EventBrite

- Find your school name and click on it, click on the red "Reserve a spot" button, choose your course(s) by clicking on the blue + button and click on the red "Check out" button.
- You do not need to Log in. Please use the STUDENT's name in all fields asking for a name.
- Fill out all required fields, choose your payment, and click on the red "Place Order" button.

Registration is due **before Monday, September 18, at 11:30pm cdt** for courses that are offered in the fall or full year.

Registration is due **before Monday, January 29, at 11:30pm cdt** for courses that are offered in the spring.

Tuition and Payment

Students pay as part of the EventBrite registration and will need to have payment ready at that time. There is a nominal registration fee in order to provide and process direct billing.
