Each month during the school year as additional families are added to our group, we will submit their names, data, and membership fee to CHALC.

We will provide a CHALC Board Representative from our group to serve for a 3-year term on the CHALC Board on a rotating basis.

We will not receive a refund or credit for any families that are removed from our group's membership list during the school year.

Annual CHALC membership is from August 1 to July 31 (a school year).

I understand that liability insurance coverage is limited to the Scrawls publicized activities of member homeschool groups only.

BENEFITS OF MEMBERSHIP IN CHALC:

- 2.) County-wide dissemination of homeschool group activities, resources, announcements, and events in 10 monthly issues of the Scrawls.
- 3.) Homeschool group leaders' breakfasts/desserts at no cost to the leaders.
- 4.) HSLDA Membership Discount
- 5.) Your group's name, the names of the leaders, and a brief description of your group, will be listed on the inside cover of the Scrawls and the CHALC website.
- 6.) Liability Insurance (property only) for advertised CHALC homeschool group activities.
- 7.) Homeschool group website is available through CHALC for an additional fee. Fee waived for this school year.
- 8.) Discount for CHALC sponsored seminars and events.
- 9.) CHALC Homeschool Group Membership Rebate - Members that are involved in multiple CHALC homeschool groups can request a rebate of part of their membership fees.

RESPONSIBILITIES:

- 1.) As Homeschool Group Leaders, if you would like your group to be a member of CHALC, you must submit your application, membership list, and \$20 fee per family. If you do not have a complete list of members, submit what you have and send additional names including the \$20 fee per family to CHALC as you receive new members. It is important that you continue to submit all of your homeschool group members' names, so we can maintain an accurate homeschool group count for insurance purposes.
2. On a rotating basis, each homeschool group is required to provide a CHALC Board representative to serve on the CHALC Board for a 3-year term. When it is your turn, your homeschool group will be reminded at the beginning of the school year. Your representative will be introduced to the homeschool group leaders and voted on at the spring CHALC homeschool group leaders' breakfast.
3. A new database will be compiled each year beginning June 15th. Any group that has not submitted their Homeschool Group's information by June 15th will not be guaranteed to receive the August issue of the Scrawls. If you do not return the application for membership your group will be removed from the back page of the Scrawls.
