ADDENDUM TO CANDIDATE INFORMATION FORM SOCIAL MEMBERS AT MAGNOLIA CREEK GOLF CLUB | SOUTH SHORE HARBOR COUNTRY CLUB

This Addendum is made on the date set forth below and hereby supplements and amends the Candidate Information Form to which it is attached. Defined terms in this Addendum have the meanings ascribed to them in the Candidate Information Form unless otherwise set forth herein. Club and Member agree and acknowledge that, as a Social Member of **Magnolia Creek Golf Club** | **South Shore Harbor Country Club** (the "Club"), Member's Social Membership includes access to The Golf Performance Center, allowing Member to enjoy certain benefits subject to the terms and conditions stated herein.

- 1. <u>Temporary Dues Reduction</u>. Commencing on the date of this addendum, Member may enjoy a reduction of \$\frac{\$}\$ off of his/her base monthly dues rate through the earlier of: a) twelve consecutive months thereafter and b) the date upon which Member ceases to maintain his/her Social Membership in good standing. Upon the expiration of the foregoing term, Member's monthly dues will revert to the standard rate for Member's category and classification of membership.

- 3. <u>Cancellation; Children; Attire</u>. Member agrees and acknowledges that there is a 24-hour cancellation policy. Soft spikes and proper golf attire are required (collared shirt, no denim).
