**ADDENDUM TO CANDIDATE INFORMATION FORM  
SOCIAL MEMBERS AT MAGNOLIA CREEK GOLF CLUB | SOUTH SHORE HARBOR COUNTRY CLUB**

This Addendum is made on the date set forth below and hereby supplements and amends the Candidate Information Form to which it is attached. Defined terms in this Addendum have the meanings ascribed to them in the Candidate Information Form unless otherwise set forth herein. Club and Member agree and acknowledge that, as a Social Member of **Magnolia Creek Golf Club | South Shore Harbor Country Club** (the "Club"), Member's Social Membership includes access to The Golf Performance Center, allowing Member to enjoy certain benefits subject to the terms and conditions stated herein.

1. **Temporary Dues Reduction.** Commencing on the date of this addendum, Member may enjoy a reduction of \$ \_\_\_\_\_ off of his/her base monthly dues rate through the earlier of: a) twelve consecutive months thereafter and b) the date upon which Member ceases to maintain his/her Social Membership in good standing. Upon the expiration of the foregoing term, Member's monthly dues will revert to the standard rate for Member's category and classification of membership.

2. **Performance Center Privileges.** The Golf Performance Center Privileges may be enjoyed by Member, his/her spouse or spousal designee and any qualified dependents as defined by the Club's Rules and Regulations. The Golf Performance Center Privileges include:

- a. Professional individual golf instruction starting at the preferred rates of \$20.00 per half-hour lesson and \$40.00 per hour lesson at Magnolia Creek and South Shore Harbor only (lessons are based upon availability; rates are subject to applicable taxes and customary increases);
- b. Discounts on Golf Performance Center services, including club fittings, TPI screenings and more;
- c. Access to the Magnolia Creek and South Shore Harbor golf courses only after 3:00 p.m. in exchange for a \$35.00 pay-per-use cart and green fee;
- d. Discounted entry for juniors into summer camp and select junior golf programming throughout the year at the Club; and
- e. Priority access to select clinics and tournaments, and other privileges determined by the Club from time to time in its sole and absolute discretion.

3. **Cancellation; Children; Attire.** Member agrees and acknowledges that there is a 24-hour cancellation policy. In the event that Member does not show for a scheduled lesson, Member will be charged a "no-show" fee equivalent to the cost of the lesson booked with the instructor. Member understands and agrees that children under 16 years of age must be signed in by a parent or guardian and children 11 year of age and younger must be accompanied by a parent or guardian while on Club property. Soft spikes and proper golf attire are required (collared shirt, no denim).

4. **Governing Documents.** Member agrees that at all times Member's membership is governed by and subject to the Club's Rules and Regulations and the Candidate Information Form (collectively, "Membership Documents"). To the extent this Addendum may conflict with the Membership Documents, the terms of this Addendum control.
