

**GRACE CHRISTIAN ACADEMY  
INDEPENDENT CAMPUS ARRIVAL AND DEPARTURE  
WAIVER, RELEASE, HOLD HARMLESS AND INDEMNITY AGREEMENT**

**1. General Campus and Arrival Policy.** Parents must physically bring students to school and pick them up after school. This policy is mandatory for all students in grades 1 through 8. This policy is also mandatory for students in grades 9 - 12, with the exceptions set forth in this document.

**2. Independent Campus Arrival and Departure.** Students in grades 9 -12 may **arrive and depart from campus independently provided that:**

A. Both of the student's parents (or a legal guardian) consent to the student's Independent arrival and departure from campus;

B. The student must check in with the office immediately upon arrival and Immediately before departure;

C. If the student is driving a motor vehicle, the student must have a valid Texas Driver=s license and must present proof of liability insurance;

D. The student is not permitted to transport other GCA students;

**3. Waiver, Release and Hold Harmless.** **The undersigned, being the parents (or legal guardian) of \_\_\_\_\_ (the student), waive application of the Grace Christian Academy Campus Arrival and Departure Policy and agree that the student may arrive at and depart from the Grace Christian Academy campus independently. On behalf of ourselves and the student, I/we release Grace Christian Academy, its agents, employees, board members, and insurers from any and all demands, liability, claims, suits, damages, or causes of action arising from the student=s unsupervised and independent arrival, failure to arrive, or departure from the Grace Christian Academy campus, of any kind or description whatsoever, including without limitation any claims arising from the alleged negligence (whether sole, joint, or concurrent), gross negligence, strict liability or other legal fault of Grace Christian Academy, its employees, agents, or directors to the fullest extent permitted by applicable law.**

**I/we further agree to indemnify and hold harmless Grace Christian Academy, its agents, employees, board members, and insurers, from any demands, liability, claims, suits, damages, or causes of action (including attorney's fees and other costs of defense) whatsoever asserted by any third party arising from student's unsupervised and independent arrival, failure to arrive, or**

departure from the Grace Christian Academy campus, , including, without limitation, any claims arising from the alleged negligence (whether sole, joint, or concurrent), gross negligence, strict liability or other legal fault of Grace Christian Academy, its employees, agents, or directors to the fullest extent permitted by applicable law.

We further acknowledge that Grace Christian Academy is under no obligation to inform us of student’s failure to arrive at school on time.

**4. Authority to Restrict Use of Motor Vehicle.** If the student has been provided with a motor vehicle, Grace Christian Academy, its employees, agents, or board members do not have authority to prohibit the student from driving the vehicle.

**5. Termination of Independent Arrival and Departure.** Grace Christian Academy may, at any time and in its own discretion, terminate the student’s permission to arrive or depart from campus independently.

**6. No Transportation of Other Students.** The permission granted in this document does not extend to permit transportation of any other student in a motor vehicle.
